DEAR FOLKS

I RECEIVED TWO LETTERS, DATED 22 AND 25, AND THE TWO ENVELOPES ABOUT TEXAS D, DATED 26, YESTERDAY. I WAS VERY GLAD TO GET THE INFORMATION AND WAS PARTICULARLY INTERESTED IN ONE PART IN THE LAW MANUAL

WHICH STATES THAT VETERANS OF WORLD WAR 2 COULD ENTER LAW SCHOOL WITH ONLY 60 CREDITS ^{points} IF THEY HAD A C AVERAGE IN ALL SUBJECTS. THAT MEANS THAT I COULD GET IN LAW SCHOOL IN TWO YEARS WITHOUT GOING TO SUMMER SCHOOL. IF I CAN MAKE A B AVERAGE IN ALL SUBJECTS FOR TWO YEARS, I WOULD BE REQUIRED TO TAKE ONLY HISTORY AND GOVERNMENT. I WOULD HAVE MY CHOICE OF STUDYING BUSINESS ADMIN. OR ARTS. FOR THE TWO YEARS AND THEN IF I DIDNT MAKE A C AVERAGE I COULD GO AHEAD AND GET A DEGREE IN ONE OF THE TWO AND ENTER LAW SCHOOL THEN.

I HOPE THAT YOU WILL BE ABLE TO FIND ME A NICE PLACE TO STAY BECAUSE I DONT THINK THAT I WILL BE HOME BEFORE LAST OF JULY OR FIRST OF AUG. AND THAT WOULDNT GIVE ME MUCH TIME TO LOOK AROUND. I HOPE THAT YOU WILL CONTINUE TO SEND ME ALL THE INFORMATION ON TEXAS THAT YOU CAN GET SO I WILL BE ABLE TO PICK THE SUBJECTS OUT IN ADVANCE.

THERE IS STILL NO FURTHER DEFINITE WORDS ON WHEN AND IF THE ARMY WILL TAKE OVER. HOWEVER EVERY DAY THERE IS A HIGH RANKING ARMY OFFICER UP HERE LOOKING AROUND AND TALKING TO THE CO. I THINK IT IS ALL A BUNCH OF NONSENSE BECAUSE NOT A SINGLE MAN DOES ANY WORK AT ALL AND THEY CLAIM THAT THEY ARE SHORT OF MEN.

IF YOU SEE ANY GOOD LOOKING SHOES OR CLOTHES THAT YOU THINK I MIGHT LIKE PLEASE BUY THEM FOR ME BECAUSE I DONT THINK THAT I WILL BE HOME IN TIME TO DO MUCH SHOPPING. IF THEY LOWER VERMONT POINTS TO EQUAL THE OTHERS AND CONTINUE TO LOWER THE OTHERS AT 2 POINTS A MONTH AS THEY HAVE BEEN DOING IN THE PAST THE POINTS WILL BE DOWN TO 74 IN JULY AND I WILL HAVE 74 AND 1/2 IN JULY.

HE WILL BE PAID TOMORROW AND I AM GOING TO SEND YOU A CHECK FOR \$ 550
I WILL INSURE IT AND HAVE THE LETTER REGISTERED, I THINK THAT IT WILL HAVE
ENOUGH PROTECTION. YOU CAN PUT THE MONEY IN THE BANK OR BONDS OR USE
FOR ANY INVESTMENT THAT YOU THINK WILL BE WISE.
